In order to file your **CHAPTER 13** bankruptcy, **copies** of the following documents are required:

- Prior 6 months of household income normally paystubs, or social security benefits letter stating your income** (this is household income – we need both husband & wife if married)
- Federal & State Tax returns – 2012 and 2011**
- Vehicle Titles** (boats, cars, trailers, motorcycles, etc.)
- Deed and Mortgage – Recorded Copy showing Date and Page** (if you own Real Estate)
- Copy of Driver's License and Social Security Card** ( you must have this for your hearing)
- Fill in the client intake on our website with your information** [www.bankruptcy-divorce.com](http://www.bankruptcy-divorce.com)
- Include the Name, Address, Amount and Account Numbers of Debts in the intake** (free copies of your credit report are at [www.annualcreditreport.com](http://www.annualcreditreport.com) call toll free at 1-877-322-8228).
- Name and Address of Recipient of any Child Support and Alimony Paid that you pay**
- Proof of Large or Extraordinary Expenses** (if applicable – large medical, charitable, etc)
- Credit Counseling Certificate** can be done online or by phone we prefer [www.bkcert.com](http://www.bkcert.com) phones are answered 24/7 866-859-7323 or [www.financiallit.org](http://www.financiallit.org) both cost 50.00  
[www.cricketdebt.com](http://www.cricketdebt.com) will give you a free copy of your credit report for 36.00; the cheapest seems to be mybknow.com and here is a code for a 10 dollar discount [2537DTMV](http://2537DTMV)
- Filing Fee (\$310.00)**
- Attorney's Fee is paid through the bankruptcy court as payments are made.**
- If you are stripping a 2<sup>nd</sup> mortgage or judgment lien – complete form from attorney.**
